3. Hazard identification

Hazard Description

Toxic. Contains a pharmaceutically active ingredient.

Handling should only be performed by personnel trained and familiar with handling of potent active pharmaceutical ingredients. Moderate to severeirritant to the skin and eyes.

4. First aid measures

After Inhalation

If inhaled, remove to fresh air; if breathing is difficult, give oxygen; if breathing stops, give artificial respiration After skin contact

Flush with copious amounts of water; remove contaminated clothing and shoes; call a physician After eye contact

Check for and remove contact lenses and flush with copious amounts of water; assure adequate flushing by separating the eyelids with fingers; call a physician

After swallowing

If swallowed, wash out mouth with copious amounts of water; call a physician

Water spray, carbon dioxide, dry chemical powder or foam

Protective equipment

Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.
