7. Substrate A (6ml): 0.05% 3,3',5,5' tetramethylbenz-idine (CAS# 54827-17-7).

8. Substrate B (6ml): 0.5% sodium citrate (CAS#6132-04-3), 1% Citric Acid (CAS# 77-92-9).

9. Stop Solution (6ml): 0.5mol/L H₂SO₄ (CAS# 7664-93-9).
