#### 4. First Aid Measures

**Ingestion:** If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

Large spill: Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas.
