## Goat anti Rabbit IgG (heavy and light chains), conjugated with Biotin (orb21606)

**Description** 

Biotin-conjugated IgG fraction of polyclonal goat antiserum to Rabbit IgG, heavy and light chains. In immunocytochemical and immunohistochemical staining to identify and measure IgG, antigen or antibody, at the cellular and subcellular level by staining of appropriately treated cell and tissue substrates, and to demonstrate circulating antibodies in serodiagnostic microbiology and autoimmune diseases; to identify a specific antigen or immune complex using a reference antibody of rabbit origin in the middle layer of the indirect test procedure. As a second step an avidin or streptavidin conjugate of the user's choice has to be used. This immunoconjugate is not pre-diluted. The optimum working dilution of each conjugate should be established by titration before being used. Excess labelled antibody must be avoided because it may cause high unspecific background staining and interfere with the specific signal. Working dilutions fro histochemical and cytochemical use are usually between 1:100 and 1:500; in ELISA and comparable non-precipitating antibody-binding assays between 1:5,000 and 1:15,000.

**Form/Appearance** Biotin-coupled purified hyperimmune goat IgG lyophilized from a solution in

phosphate buffered saline (PBS, pH 7.2). No preservative added

**Storage** The lyophilised conjugate is shipped at ambient temperature and may be stored

at  $+4^{\circ}$ C; prolonged storage at or below -20°C. Working dilutions are prepared by adding sterile phosphate buffered saline (PBS, pH 7.2). Repeated thawing and freezing should be avoided. Working dilutions should be stored at  $+4^{\circ}$ C, not refrozen, and preferably used the same day. If a slight precipitation occurs upon

storage, this should be removed by centrifugation. It will not affect the

performance of the product.
